Financial Aid Policies

Financial Aid is applied to a student's account **over two semesters**, fall and spring in two equal parts.

This award applies for **60 ECTS credits** per academic year. If you take more than 60 ECTS credits per academic year the award will not be increased.

Students must be enrolled in **at least 24 ECTS credit** hours per semester to receive an award. If a student enrolls in less than 24 ECTS credit hours in either semester, they will not receive their financial aid for that semester (exception is made only for seniors).

Financial Aid might be offered to **seniors** during their final semester. The amount of ECTS credits must be approved by Academic VP. Only then a student can receive Financial Aid for less than 24 ECTS credits for the final semester.

Financial aid cannot be applied to **summer session courses**. If financial aid for summer session becomes available, students will be notified by email.

Students can receive only **one award** (*this does not apply to the Sibling Grant and Emergency Aid*). If a student qualifies for more than one, he/she will receive the one with the highest monetary value.

If the student has received any financial aid and has been placed on **probation** after the Spring or Fall semesters, he/she does not receive the financial aid part that has been allocated for the following semester.

If a student receives financial aid and then decides to take an **academic leave**, he/she loses the award. The student is then informed of the dates for Need-Based Aid application for the next academic year.

Students can get financial grants **only for four years at LCC or up to 8 semesters** (*calculation would be done by semesters if a student takes an academic leave*). The academic leave period is calculated towards the 8 semesters rule. If students study longer or take a second major, they must find their own financing opportunities. PRIME program is not calculated towards the 8 semesters rule.

The maximum financial aid amount that a student can receive is **90% tuition discount** (*all financial aid amounts summed up*). This does not apply to the Kenneth & Helen Penner, President Leadership Scholarships and Ukraine/Caucasus/International Scholar Awards, Middle East Scholar Aid.

Financial aid is not applied for the **retaking a failed course "F"**. Receiving an "F" for a course might affect a student's satisfactory academic progress and eligibility to receive financial aid in the future.

Students receiving financial aid that **withdraw or stop attending classes** will be required to return financial aid received.

Students must be **under 25 years of age**. If a student turns 25 years of age during a specific semester, financial aid is not applied for that semester.

Financial Aid is available for students who are seeking the **first Bachelor degree** only. If a student during the Bachelor studies at LCC simultaneously receives another Bachelor's degree from another university, financial aid will be removed for the following semesters.

All Financial Aid at LCC International University is based on **availability of funds**. Therefore, students and their families must take primary responsibility for meeting the costs of education at LCC International University.

Global Grant (NB Aid)

To receive NB Aid for 2024-2025 you will have to go through the following steps:

STEP#1 Check your eligibility. Please see the detailed list of eligible countries below:

Africa: Algeria, Angola, Benin, Botswana, Burkina Faso, Burundi, Cabo Verde, Cameroon, Central African Republic (CAR), Chad, Comoros, Democratic Republic of the Congo, Republic of the Congo, Cote d'Ivoire, Djibouti, Egypt, Equatorial Guinea, Eritrea, Eswatini, Ethiopia, Gabon, Gambia, Ghana, Guinea, Guinea-Bissau, Kenya, Lesotho, Liberia, Libya, Madagascar, Malawi, Mali, Mauritania, Mauritius, Morocco, Mozambique, Namibia, Niger, Nigeria, Sierra Leone, Rwanda, Senegal, Seychelles, Somalia, South Africa, South Sudan, Sudan, Swaziland, Tanzania, Togo, Tunisia, Uganda, Zambia, Zimbabwe.

South America: Argentina, Bolivia, Brazil, Colombia, Ecuador, Guyana, Paraguay, Peru, Suriname, Venezuela.

Central America: Belize, Guatemala, El Salvador, Honduras, Nicaragua, Costa Rica, Panama, Mexico, Dominican Republic, Dominica.

Indian Subcontinent: Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan, Sri Lanka.

South-Eastern Asia: Indonesia, Malaysia, Thailand, Timor-Leste, Vietnam, Philippines.

STEP #2 Fill out and submit this form together with supporting documents to Student Financial Services office #23 (Defehr).

The application is considered complete, if:

- the application is completely and correctly filled out,
- all required documents with official translations (if applicable) are attached,
- all required documents are official (no photocopies or scanned documents),
- all required documents represent information for the recent 12 months period.

APPLICATION DEADLINE:

November 15, 2023 (PRIME - Junior). Late NB Aid application forms will not be accepted.

IMPORTANT:
The application is complete once Student Financial Services coordinator accepts the application package and informs about the next steps, such as interview with Student Financial Services director.

TIPS TO REMEMBER when filling out a NB Aid application:

Application must be filled out in **English**.

Documents should be submitted in **Lithuanian or English** only. If your documents are in a different language, please submit an official translation together with the original document.

Only official documents will be accepted. A document is considered as official, if it has an institution's that issued the document stamp and its representative's signature.

All financial information must be completed in the student's **national currency or in euros**.

Do not leave any questions blank. If your answer is 0, please use a "0".

If a question does not apply to you, please use the abbreviation "N/A". Incomplete information may delay the processing of your application.

The completed application becomes the **confidential property of LCC** and is not returnable. Applicants are responsible for ensuring that all the information and accompanying material provided in connection with their application is **authentic and accurate**. FALSELY REPRESENTED INFORMATION WILL VOID FINANCIAL AID AND COMPROMISE YOUR STANDING AS A STUDENT AT LCC INTERNATIONAL UNIVERSITY.

LCC may at any time require applicants to provide **satisfactory verification** of the information and documents submitted as part of their application. If an applicant is unable to do so, the University reserves the right to cease consideration of the application and to withdraw any offer of financial aid already made.

Only complete Global Grant NB Aid applications with required documentation will be processed.

STEP #3 Interview.

Returning students will be invited for an interview with the Student Financial Services Director. Interviews will be conducted with students over October 2023-January 2024 period. You will be informed about the exact date and time in advance. If you miss the interview, the Need-Based Aid Committee will not proceed with your application form.

STEP #4 Decision.

Global Grant (NB Aid) 2024-2025 decisions will be announced by the end of **March 2024**.
